Instructions to the Registered Owner:

Sections 1 and 2 must be filled out COMPLETELY.

READ AND UNDERSTAND section 3.

Print your name AND sign as the registered owner. Complete with date and time. Fax back to ASAP at 985-649-2291 or send to ASAP with the person whom you are authorizing.

A COPY of the REGISTERED OWNERS DRIVERS LICENSE MUST BE INCLUDED AND MUST BE LEGIBLE.

A copy of the vehicle registration or title must be available to ASAP. (may be in the vehicle at the time of tow, included with the return fax, or brought in by the authorized representative.

FOR A PERSON to REMOVE PROPERTY, they MUST HAVE PICTURE ID WITH THEM.

FOR A PERSON to REMOVE a VEHICLE, they <u>MUST HAVE a VALID DRIVERS LICENSE ON THEM and PROOF</u> of INSURANCE on the VEHICLE.

No transactions will occur without a copy of the vehicle registration or title and proper picture ID.

No vehicle will be driven out of the storage facility by a peson without a VALID drivers license.
